On the 18th August 1993, I together with Malcolm Cameron Foulds were monitoring in the Liverpool area following complaints of interference to broadcast radio. We heard a station transmitting on 105.1Mhz which called itself "ZEE 100".

We identified this as being an unlicensed broadcast station and we traced the source of the transmission at 20.50hours to the proximity of _____ ROAD, BIRKENHEAD. We noticed a long antenna on the roof of these premises and whilst monitoring further we heard broadcaster call himself "STEVE MOORCROFT" and he gave a telephone number for listeners to contact the station as 0850 984132.




